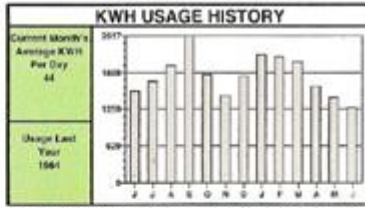

Customer Charge

Customer charge is better known as the service availability or base charge for electricity. This charge is a flat fee designed to recover a portion of the cost of delivering electric energy to members. Customer charge includes investment in poles, wires, transformers, and other equipment required to provide electricity. It also includes operational expenses, such as line maintenance & right-of-way clearing.

Demand Charge

Demand is the rate at which electric energy is used at any instant or averaged over any designated period of time and is measured in kilowatts (kW). The demand kW is measured by the electric meter as the highest average demand in any 15-minute period during the month. This is the amount of electric load required by the customer's equipment operating at any given time. Transmission and distribution utilities must have sufficient electric capacity such as properly sized transformers, service wires and conductors to meet kW demand.

Energy Adjustment

SCAEC is a distribution cooperative that does not generate any of the electricity it sells. We operate as an energy "wholesaler," buying electricity in bulk to benefit members. The energy adjustment is a charge to reimburse the Cooperative for the actual cost of the power purchased. To calculate the energy adjustment on your bill, multiply the kWH usage x current billing factor.

Cost of Debt Adjustment

At the time that rates are set for an electric cooperative, costs are required to upgrade the distribution system. Quarterly, the cooperative compares the amount of debt costs collected through its base rates and the actual debt costs incurred in its operations. To calculate cost of debt adjustment on your bill, multiply your KWH usage x the current billing factor.
